#### **1. Welcome, Apologies**

Chair welcomed everyone to the meeting, and introduced the speaker Gavin Graham.

#### **2. Speaker on the “West Leith” Controlled Parking Zone proposal**

Gavin Graham gave a presentation on the proposal for West Leith (Easter Road / Lochend Road / colonies / through to Restalrig Road). There had been an increase in complaints about on-street parking in the city, and so the council reviewed this across the city. All the survey results are available on the council website, along with consultants’ reports.

There will be four phases in the city. Phase 1 includes parts of Leith and Gorgie, where a Traffic Order is currently being taken forward. ‘West Leith’ is in the second phase. There are 124 review areas in total. West Leith is one of the areas where there is concern that parking will be displaced, when controls are introduced elsewhere in Leith. Parking pressures appear to be highest near Leith Walk and Easter Road. The council is therefore consulting residents in a variety of ways, including online, and is delivering leaflets to all addresses.

The team are trying to maximise parking for residents, with some focus on shared parking for visitors where there appears to be capacity. Mews parking areas are also proposed, where there are no marked spaces but the street is still reserved only for residents.

#### **3. Questions and Discussion**

Chair began with questions that had been submitted by the public in advance, after which the rest of
