

MINUTES AGM

1. Welcome

Acting Chair for the AGM, Cllr Munro, welcomed everyone to the meeting. Apologies were received from Deidre Brock MP.

Chair proffered congratulations on behalf of LLCC and his Councillor colleagues to Jim Scanlon for the recent much-deserved award of an MBE for his community work in Leith, and also congratulated him as a local historian and for his work at DWP.

2. Adoption of Minutes of last AGM on Monday 27 May 2019

3. Presentation of Annual Report (incorporating Reports from Chair, Secretary & Engagement Officer)

This year's Annual Report contains reports by the Chair, Secretary and Engagement Officer, and leads of all the sub-committees, and provides a summary record of LLCC's work over the year. Chair observed that much has changed due to the pandemic, but LLCC has successfully moved online and has kept engaging with the community, also using the website and social media to good effect. Commenting on specific work in the year, Chair noted that campaigning on Seafield sewage works, with Ben Macpherson MP's assistance, has led to additional funding for new sewage works.



Secretary noted that sadly LLCC has had to forego the events where councillors meet members of the local community, this year. The pandemic has highlighted how disadvantaged people are if they lack access to digital technology. Similarly, there have been fewer opportunities for public scrutiny. of planning applications, and there is much new development planned for our area, which has been a major work area for LLCC during the year,

4. Treasurer's Reports & Presentation of Accounts

LLCC has two bank accounts: the main one for the general running of LLCC, and a Project Account exclusively for £eith Chooses. Details for the main account are in the Annual Report. Main income was a grant of £737.74 from City of Edinburgh Council. The expenditure through the year included minutes, website, insurance, data protection, flyers for the AGM, and the Leith Festival Gala Day. LLCC also supported Leith Links Residents Association in its legal campaign on Seafield. The closing bank balance at 31 March 2020 was £2078.51.

Details of the Project Account: the only income was cash donations from Steering Group members and Community Councillors. All expenses were related to publicity and running the voting event. The closing bank balance at 31 March 2020 was £286.97, which has since reduced to £145.33.

5. Updates, Comments / Remarks, and Adoption of Annual Report(s)

Adoption of the Annual Report and the Accounts was proposed by Jim Scanlon and seconded by Chrissie Reid. It was adopted unanimously. Chair thanked Michael for producing the Annual Report in an attractive and readable format, and all the community councillors for all their contributions, bringing a wide range of knowledge and skills. Chair also thanked Sally and the team for their work on the very popular £eith Chooses events.
